



## 2018 FEE SCHEDULE

Each year the College reviews the schedule of fees we charge our parents and guardians. The fee income we receive is crucial to the successful operation of the College and the ability to meet our community's needs.

### Payment Options

Cash, Cheque, Credit Card, EFTPOS, Centrepay, BPay is acceptable. Payment Plan for Credit Cards can be arranged.

Fees are broken down into several categories:

### CATHOLIC EDUCATION OFFICE TUITION FEES

The Catholic Education Office Tuition Fee is established and charged by the Sydney Archdiocesan Catholic Schools (SACS) Board and is common to all Catholic Systemic Schools. This fee is charged on an increasing incremental basis as students progress through to the HSC and on a decreasing incremental basis for the second and subsequent child attending a Sydney catholic Systemic School.

It contributes to:

- Resources for schools
- Student accident insurance
- Public liability
- Volunteer workers insurance

**The sibling reduction is 10% for the second child and 35% for the third child in the system, with any subsequent children in the system free of charge.**

## BUILDING LEVY

This fee is a per family charge for the purpose of servicing debts owing on the construction of the College's buildings and facilities. The amount is **\$535.00 per annum**.

If there are students from the one family in more than one Catholic systemic school in the Archdiocese, then the Building Levy is charged equally between the schools.

## SUBJECT AND RESOURCE FEE

This fee covers the cost of conducting the educational programmes and providing educational experiences, equipment, materials and resources. The amount is as follows:

<b>Year 9 &amp; 10</b>	\$773.00 per annum
<b>Years 11 &amp; 12</b>	\$886.00 per annum

**VET & Trade Training Courses are charged separately.**

## ADMINISTRATION FEE

The Administration Fee of **\$449.00 per annum** is used for the purpose of covering the recurrent and capital costs of operating the College, including:

- Electricity, gas and water
- Cleaning and waste management
- Postage and stationery
- Insurance costs (buildings and contents)
- Major classroom furniture and equipment items
- MCC & CCC Subscriptions
- Telephones
- Printing and photocopying
- Awards and presentations
- College newsletter and calendar
- Major repairs and maintenance projects

## ICT LEVY

The Technology fee of **\$404.00 per annum** pays for the use of student internet and ICT services as well as services provided by the Catholic Education Office and external providers.

## EXCURSION FEE

The Excursion Fee is charged per year cohort. The excursion costs are supplemented by the College, therefore **non attendance is not refundable**.
